Only Nicaraguan-source income is taxable. Personal income tax is progressive with a top rate of 30%, the corporate rate is 30%, and the VAT (IVA) rate is 15%. Nicaragua has free trade

In Nicaragua, the sales tax rate is a tax charged to consumers based on the purchase price of certain goods and services. The benchmark we use for the sales tax rate refers to the highest rate.

## Nicaragua Tax and Accounting Requirements: A Guide

The rate is determined as the higher of either 30% of net taxable income (gross taxable income minus permitted deductions) or a fixed minimum
